

## Dog Licensing

All dogs five (5) months of age or older in the Village of Richfield are required by law to be vaccinated against rabies and issued an annual license.

Please issue separate checks for dog licenses and tax payments.



**Proof of vaccination must accompany the application in order to receive a license per WI State Statute 95.21 (20) (A).**

Cats do not need to be licensed.

## Animal Fancier's Permit


Anyone having more than three (3) dogs over the age of five (5) months will need an Animal Fancier's Permit, per Village Ordinance. The cost of this permit is \$30, plus the regular dog license fee for each dog.

These permits can be obtained at the Village Hall during normal business hours.

## 4 Convenient Ways to Pay

### 1. Pay By Mail

#### Important By Mail Reminders:

Payments must be postmarked on or before due date to be considered timely. All returned checks will be charged \$30. Returned checks will void payment.

To receive a receipt, please send along with your payment, a self-addressed and stamped envelope.

Allow ten (10) business days to receive a receipt, if requested.

Checks issued by lenders must be endorsed by all parties listed as payee.

### 2. Night Deposit

Located at Village Hall, to the left of the main entrance, the drop box is a secure depository for payments available 24 hours a day. Follow the same day instructions as if you were mailing. Tax payments are removed and processed daily.
